In the identified area, the current year population is 75,043. In 2010, the Census count in the area was 72,810. The rate of change since 2010 was 0.33% annually. The five-year projection for the population in the area is 76,162 representing a change of 0.30% annually from 2019 to 2024. Currently, the population is 48.6% male and 51.4% female.

Median Age

The median age in this area is 39.6, compared to U.S. median age of 38.5.

Current median household income is \$113,101 in the area, compared to \$60,548 for all U.S. households. Median household income is projected to be \$125,473 in five years, compared to \$69,180 for all U.S. households

Current average household income is \$154,902 in this area, compared to \$87,398 for all U.S. households. Average household income is projected to be \$172,255 in five years, compared to \$99,638 for all U.S. households

Current per capita income is \$55,223 in the area, compared to the U.S. per capita income of \$33,028. The per capita income is projected to be \$61,289 in five years, compared to \$36,530 for all U.S. households

Currently, 82.8% of the 27,703 housing units in the area are owner occupied; 14.0% renter occupied; and 3.2% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 27,186 housing units in the area - 84.7% owner occupied, 11.2% renter occupied, and 4.1% vacant. The annual rate of change in housing units since 2010 is 0.84%. Median home value in the area is \$354,658, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 0.94% annually to \$371,648.
