In the identified area, the current year population is 134,335. In 2010, the Census count in the area was 131,548. The rate of change since 2010 was 0.23% annually. The five-year projection for the population in the area is 136,666 representing a change of 0.34% annually from 2019 to 2024. Currently, the population is 48.4% male and 51.6% female.

Median Age

The median age in this area is 47.3, compared to U.S. median age of 38.5.

Current per capita income is \$54,410 in the area, compared to the U.S. per capita income of \$33,028. The per capita income is projected to be \$60,916 in five years, compared to \$36,530 for all U.S. households

Currently, 78.3% of the 52,515 housing units in the area are owner occupied; 18.1%, renter occupied; and 3.6% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 51,827 housing units in the area - 80.7% owner occupied, 15.0% renter occupied, and 4.3% vacant. The annual rate of change in housing units since 2010 is 0.59%. Median home value in the area is \$331,755, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 1.09% annually to \$350,259.
